Based on the currently valid association statutes for 2024, the owner of this permit booklet is granted the revocable permit to fish in the waters specified on the following pages to the extent described, if he/she by **personally signing** the "General Provisions" (pages 5 - 7) confirms that he/she **has taken note** of all the provisions of this permit.

The relevant legal provisions apply (fishing law, animal protection law, regulations on non-profit status, etc.), without these being printed in detail on the permit. The provisions of the Federal Data Protection Act (BDSG) and the EU General Data Protection Regulation (GDPR) are observed. Official regulations, e.g. to prevent forest fires or to protect against infection, must also be observed at the NWA waters.

In the event of violations, the permit will be confiscated immediately.

Special permit for the use of roads

Dear Ladies and Gentlemen.

at your request I grant you, pursuant to article § 46 paragraph 1 no. 11 of the German Road Traffic Code (StVO), subject to revocation at any time, the special permit to use the road Burlager Ort / extension Strubbenweg up to Alfsee-Damm, which is blocked by sign 250 StVO ("Prohibition for vehicles of all kind").

Conditions:

- The path may only be driven at walking speed.
- You have to release the Samtgemeinde [joint community of] Bersenbrück from all claims that may
 arise from driving on the path or the use of the road by third parties (exemption from liability and
 traffic safety obligations)
- The holder of the licence is liable for all personal and material damage caused by driving on the road.
- The police and the employees of the Specialist Service of Order, Citizens' Service and Social Affairs of the Samtgemeinde [joint community] of Bersenbrück are entitled to issue instructions that deviate from the regulation of this permit. Such orders must be complied with without delay.
- This permit is valid only in its original (version) and must be handed over to the competent persons for examination upon request.
- Pedestrians are to be taken into special consideration

Advice on applicable remedies

An action against this decision may be brought to the Administrative Court of Osnabrück, Hakenstraße 15, 49074 Osnabrück, within one month after notification in writing or for recording by the official of the registry office of this court.

2. General Provisions

Each member is required to be considerate of one another and to behave in such a way that the reputation of the NWA is not damaged. In particular, no one may be harassed, endangered or even harmed. Excessive consumption of alcohol and noise should be avoided.

- The fisheries supervisors have the right to withdraw the permit temporarily in the event of violations of the rules if verbal instruction / warning on site is no longer sufficient due to the seriousness of the violation.
 - The permit must be handed over to the fisheries supervisor for inspection.
- The fisheries supervisors are to be supported in every way. Their instructions must be followed.
- 3. Each caught and removed fish is to be treated with due care (in particular, the use of lip grips and gaffs is prohibited) and immediately entered in the catch list. Furthermore, all necessary equipment/utensils for proper treatment (especially landing and killing) and for filling out the catch list must be carried. The weight of the fish must be added to the catch list before the next fishing day, but no later than 72 hours. When returning the permit, please mark on the front whether you have fished.
- 4. Neither the NWA nor the lessors or property owners are liable for accidental damage of any kind.
 With his signature, the holder of this permit already assigns to the NWA any claims for damages to which he is entitled in the event of damage to the fish population by a third party against the damaging party. The assignment is accepted.
- 5. Banks, embankments, dikes, towpaths and green areas must be kept free of any kind of waste. Dikes, towpaths, embankments, riparian zones and plantings may not be damaged, meadows and fields may not be entered. Driving on with motor vehicles/car trailers is prohibited. Likewise, bathing, wading and entering waters (except for fly and spin fishing), as well as entering islands is prohibited.
- Parking on NWA car parks is only permitted for association purposes with a clearly visible valid badge. Badges may not be passed on and may not be used by third parties.
- 7. Camping is prohibited on all NWA waters. Open fires are forbidden; Smaller grilling activities with suitable grilling equipment for personal use are permitted. Only weather protection for anglers/with fishing character with a ground space of 6.5m² is permitted. This weather protection has to be placed in such a way that third parties will not be hindered.

- 8. The use of model boats for the purpose of fishing or baiting is prohibited (observe exceptions in certain waters).
 - Fishing from boats is only permitted on the Kronensee, the Linner See and the **Niedringhaussee** in compliance with the legal provisions and the additional regulations (see summary of the text in Chapter 7).

Belly boats: see regulation boats (these apply), additional waters Schleptruper See. In principle, spawning areas, closed water areas or reed and reed stocks may not be navigated. Trolling is prohibited in all NWA waters. Belly boats and boats are approved for active fishing only. Deploying rigs/bottom rods, baits, baiting materials, etc. bank fishing is not permitted with them. The carrying along of any kinds of motors at or on the waters is also forbidden.

- Fishing is not permitted on and in spawning areas.
- 10. **Undersized or protected fish or fish** not considered in the extraction window are to be carefully released from the hook and gently put back. The regulations concerning the extraction window have to be observed.
- Only dead bait fish may be used. Grayling, trout, pike, crucian carp, carp, nase, tench, zander and all year-round protected fish species are prohibited as bait fish. Electrically powered baits are prohibited.
- 12. Fishing rods that are laid out must be **personally** supervised by the permit holder (animal protection law). The angler must remain in the immediate vicinity of the fishing rods he has laid out.
- 13. Eel lines and traps are prohibited on all NWA waters (animal protection law).
- 14. The established rules apply to baiting in all NWA waters:
 - 1. Baiting must be in direct temporal connection with the fishing, i.e. creating feeding places in the run-up to a fishing appointment is not permitted.
 - 2. During the fishing day, 2 liters (2 kg of dry bait) approved fishing bait plus 1 liter of undyed maggots may be introduced into a body of water. More than this permitted amount of feed material may not be carried along on the water.
 - Baiting with typical animal food for mammals (e.g. dog or cat food) is prohibited in any form (also as compound feed) for ecological and ethical reasons. This also applies to other animal food that meets the requirements of the Animal Feed Act.

These measures serve to protect the waters and the members who behave on the waters according to the regulations.

- Only single hooks may be used for fishing for coarse fish. Paternoster fishing (i.e. several single or multiple hooks per rod) and the **snapping** of fish are prohibited.
- 16. Fishing is only allowed in clean fishing spots. The fishing spots and the surrounding area must be left clean and free of any rubbish (excrement must be disposed of in an environmentally friendly manner). Carrying disposable packaging for bait and baiting material is prohibited on the water!
- 17. Dogs are to be kept on a leash on all NWA waters.
- 18. Every angler is obliged to show mutual consideration and only lay out his rods/bait so far that other anglers in the near/long range are not restricted. This applies equally to shore anglers as well as (belly-) boat anglers and bait boat users. Reckless behavior is not only uncomradely, it can also result in the withdrawal of the permit. 20 meters of shoreline per angler are considered sufficient.
- 19. Scope of permission on all waters unless otherwise stated: Approved: all year round. Equipment: 1 spinning rod or 1 drop-shot rod or 3 rods (of which only 2 predatory fish rods) or 1 bait fish sink max. 1x1 m or 1 crab dish.
- In the period from 01.01. until 30.04. it may not be fished with baitfish or artificial lures (spoon, wobbler, twister, fly, etc.) in any NWA waters. Exceptions:
 - 1. In the canal stretches, the use of bait fish and artificial bait is only prohibited during the zander closed season (note NDS and NRW).
 - 2. In the waters no. 115, 118, 171 and 172, a separate permit scope is regulated for each body of water (see also the description of the body of water). In these waters, fishing is only permitted with soft hooks or hooks with pressed barbs. This regulation also applies to spin fishing.

21. Key to NWA waters

NWA waters that can only be accessed with a key (available from the office) are marked with the "key" symbol. Passing on keys to non-members is prohibited. Gates and barriers must be locked again immediately after passing.

I have understood all the provisions of this permit and undertake to comply with them conscientiously. In the event of violations, the management board and fisheries supervision are entitled to confiscate the permit. I recognize resolutions of the Board of Directors and the Board of Directors as well as any decisions of the Honorary Committee as binding for me.

The following fish species are to be removed from the water when caught and killed immediately. They have no closed season and no minimum size and may not be introduced into any other waters: black-mouthed goby, sunfish, largemouth bass, Volga zander, blue-banded rasbora.

Extended regulation only for black-mouthed gobies:

Black-mouthed gobies are only permitted as bait fish in the canal sections, in the Hase (water body no. 145 and no. 148) and in the Alfsee feeder (water body no. 504).

Attention, in the period from 01.01. until 30.06 a maximum of 10 fish may be taken in the Hunte (water body no. 151 and 152) per day. The catch limit per fish species must be observed all year round.

7. Waters

Extraction window

The bodies of water for which the extraction window (see Chapter 4.) applies are marked with a window symbol ().

Key to NWA waters

The waters that are only accessible with a key are marked with a key symbol ()

Boat use

The waters where boating is permitted are marked with a boat symbol (). The following specifications for the waters approved for boat use must be observed:

- The use of boats (not motorized!) for the purpose of fishing is permitted in the marked waters.
- Prior registration at the NWA office is required.
- Each user must inform himself in advance about the current regulations for boat use (homepage or office).

Bait boats/model boats

The waters where the use of model boats for fishing or baiting purposes is permitted are marked with a remote control symbol (). The General Provisions, Item 14, must be observed.

7.1 Running waters

Body of water no. 101 - Deeper Aa

In Freren from the Fürstenau district border near Settrup to the "Schapener Straße" road bridge.

Body of water no. 102 — Große (Large) Aa

From the "Schapener Straße" road bridge to the "Langer Wall / Kuhlort" road bridge.

Body of water no. 103 - Schaler Aa

In Freren from their entry into the Ward to the confluence of Deeper Aa.

Body of water no. 104 - Ahe

In the parish of Freren in the municipality of Settlage to the estate "Gut Hange".

Body of water no. 110 - Bühner Bach

Beginning: see water map, end: confluence into the Hase.

Body of water no. 112 - Recker Aa

From Wöstewiesen (east of Kowallstrasse) to south of Hammermühle (municipal boundary of Hopsten).

- Pay attention to the signs and restricted areas. The Alkemeier car park may only be accessed via the Maiwiese access road.
- From 15.02. until 15.03. closed for any fishing.

Body of water no. 115 — Düte (NDS)

From the Georgsmarienhütte factory to the state border with North Rhine-Westphalia (behind campsite Attersee).

- please note the scope of permission listed separately (see text below).
- 50 m above and 50 m below the Sohlgleite entering the bank and waters and fishing is prohibited.
- Attention! In the street "Im Stavern" in Georgsmarienhütte-Holzhausen (path to the Düte) there is a ban on stopping along the entire route, which also applies where the street turns into a private road.
- Attention! Fishing (including spin fishing) is only permitted with barbless hooks or hooks with pressed barbs.

Body of water no. 118 - Düte (NRW)

From the state border of North Rhine-Westphalia to the confluence with the Hase.

- please note the scope of permission listed separately (see text below).
- Fishing is prohibited from the Mühle Bohle bridge up to 30 m upstream on both sides up to the pasture fence.
- Fishing is prohibited from the Bohle mill to 30 m below (area of pothole and fish ladder).
- Attention! Fishing (including spin fishing) is only permitted with barbless hooks or hooks with pressed barbs.
- Attention! The private road in the area of the "Tüchters Mühle" (as indicated by the signs) of the street "Alter Mühlenweg" in Lotte/Wersen may not be used.
- New barrier section approx. 30 meters upstream on both sides starting at the wooden bridge Tüchters Mühle (signs on site).

Scope of permission for the Düte sections (No. 115 and No. 118):

- From 15.10. until 15.03. closed to all fishing.
- From 16.03. until 15.05. fishing only with a rod and artificial bait. Fishing with imitations of maggots or worms is not permitted.
- From 16.05. until 14.10. fishing with 2 rods or 1 spinning rod or 1 sink or 1 crab plate with any kind of bait.

- Driving and parking for motor vehicles of all kinds is prohibited on the access roads and on the grounds of the Mühle Bohle!
- Please also note the list of closed sections on the NWA homepage (www.nwaev.de)!

Body of water no. 120 - Elze

From the Hunteburg-Damme road to the confluence into the Hunte.

Body of water no. 125 - Flöte

From the municipal boundary of Vörden-Hörsten to the confluence into the Aue in Horsten.

Body of water no. 130 - Großer Dieckfluss (NRW)

From the city-community border of Pr. Oldendorf – Stemwede, Street Am Schierenfeld near the L 557 Oldendorfer Straße (towns of Getmold / Destel) to the city border of Rahden – Stemwede.

- The end point is indicated by signs placed on both sides with the inscription "Fishing border Stemwede – Rahden".

Body of water no. 131 - Twiehauser Bach (NRW)

From the triangle Lübbecker Str., Gestringer Str., Erfmeyer Str. near the Rethlage (towns of Destel / Vehlage) to the confluence with the Großer Dieckfluss, near the Twiehauser Straße.

Body of water no. 142 - Hase

From the estate (Gut) Stockum to the Fledder railway bridge (approx. 100 m below the entrance of the Schoellergraben).

- From the estate (Gut) Stockum to the Natberger bridge, fishing on the side of the manor is prohibited from 01.10. until 31.12.

Body of water no. 143 - Hase

Fledder railway bridge to Halen/Hollage bridge.

- Fishing between the weir at the roundhouse (Hamburger Straße) and the Schellenberg Bridge (along the railway tracks) is prohibited.

Body of water no. 144 — Hase Halener Feld

From the Halen/Hollage bridge until the Mittelland Canal.

Body of water no. 145 - Tiefe (Deep) Hase

Distribution structure on the road between Hesepe and Sögeln/Malgarten up to the municipal boundary of Rieste/Sögeln.

- In the months of November and December fishing in the sections 145 and 148 is prohibited on Tuesdays.

Body of water no. 148 – Hase

From Meschers bridge in Bersenbrück-Hertmann to Narbers bridge in Badbergen-Wulften (approx. 1 km north of the Badbergen/Dinklage road bridge).

- In the months of November and December, fishing in route 145 and 148 is prohibited every Tuesday.

In the fenced area/terrain of the Hase branch (on the west side of the Hase) entry and fishing are forbidden.

Body of water no. 149 – Haseteich (Hase pond) Gehrde



Located in Gehrde-Rüsfort near the Gehrder bridge.

Body of water no. 151 – Hunte

From the bridge "Osnabrücker Str. - old B 51" in Bohmte to the bridge "An der Oelmühle" in Hunteburg.

Fishing is forbidden

- from 220 m above the "Hauptstraße" to "An der Oelmühle" (ground sill)
- Attention, in the period from 01.01. until 30.06. a maximum of 10 fish may be taken per day. The catch limit per fish species must be observed all year round.

Body of water no. 152 – Hunte

From the bridge "An der Oelmühle" in Hunteburg to the confluence into the Dümmer.

Night fishing is prohibited (calendar sunset to calendar sunrise) in route sections A (Bornbach confluence until just behind the Schäferhof and the wooden bridge to the end of the permitted route)

from 1 May until 30 June of a year. See also water map, signposting or www.nwaev.de.

Fishing is prohibited

- from "An der Oelmühle" to 150 m below (Sohlschwelle/alte Mühle) in Hunteburg (near the Hauptstraße)
- in the Hunte pond (in the triangle Hunte/confluence int the Bornbach)
- from 01.01. until 30.04. (closed season for spawning)
- from 01.01, until 30.06, with twin and triple hooks of any kind (protection of species)
- additional closure times from the Bornbach confluence to the end of the permitted route must be observed due to the VO NSG "Dümmer, Hohe Sieben and Ochsenmoor" (see water map, www.nwaev.de, signposting)
- Attention, in the period from 01.01. until 30.06. a maximum of 10 fish may be taken per day. The catch limit per fish species must be observed all year round.

Body of water no. 171 – Nette (Ruller Flut)

- a) On both sides of the Nette (Ruller Flut) in Wallenhorst-Rulle, from Unländer Damm up to 50 m above Knollmeyers Mühle. Exception: On the left-hand side in Rulle, Am Haupthügel, between Sandbreite and Erlengrund and approx. 25 m (at the level of "Am Haupthügel no. 59") and approx. 44 m (behind the restaurant "Zum alten Kloster" in the Klosterstr. 17) and
- b) the right-hand side of the Nette from 50 m below Knollmeyers Mühle to the trout ponds and on sections until Böhnes Mühlenteich (Nackte Mühle)
- the left-hand side of the Nette from 50 m below Knollmeyers Mühle to the city border of Osnabrück-Haste and on sections from the trout ponds to the bypass channel in front of Böhnes Mühlenteich (Nackte Mühle).

In addition, the left-hand side of the Lechtinger Bach from the state forests until the spot where it flows into the Ruller Flut.

- Closing sections: Fishing is prohibited in the bypass channels.
- For the exact course of the sections and exceptions, see the water sketch on the Internet (www.nwaev.de).
- Scope of permission: From 15.10. until 15.03. closed to all fishing. From Niederrielager Bach to Knollmeyers Mühle on the left side blocked from 15.10. until 01.06.

- Scope of permission: From 15.10 to 15.03. closed for any kind of fishing. From the Niederrielager Bach to Knollmeyers Mühle on the left-hand side closed from 15.10. to 01.06.
- Scope of permission for number of rods: fishing is only permitted with one rod.
- Fishing is only permitted with artificial lures. Fishing with imitations of maggots or worms is prohibited.
- All fishing is only permitted with barbless hooks or hooks with pressed barbs.

Body of water no. 172 - Nette

In Osnabrück-Haste, from 50 m above "Haneschstraße" to the confluence into the Hase.

- Restricted sections: Fishing is prohibited within the enclosure of the monastery of St. Angela.
- From 15.10. until 15.03. closed to all fishing.
- From 16.03. until 15.05. Fishing only with a rod and artificial bait
- From 16.05. until 14.10. Fishing with 2 rods or 1 spinning rod or 1 sink or 1 crab plate with any bait.
- Attention! Fishing (including spin fishing) is only permitted with barbless hooks or hooks with pressed barbs.

Body of water no. 180 - Nonnenbach

Right bank in the municipality of Epe.

- Beginning 10 m below the Malgarten-Wittenfelde road bridge, end 650 m downstream.

7.2. Canal routes

Restriction for all canal routes including the Branch Canal

- Fishing is prohibited in front of the offices of the Water and Shipping Administration, in all boat ports and marinas, as well as 50 meters to the side of their entrances and the corresponding opposite banks and from transshipment points.
- Fishing is prohibited above and below as well as within lock systems, insofar as these are designated as company premises.

Body of water no. 300 - Mittelland Canal (NRW)

From km 8 on the Ibbenbüren-Hopsten-Lingen road to the Neuenkirchener bridge (km 18.72).

Body of water no. 301 - Mittelland Canal (NRW/NDS)

From the Neuenkirchener bridge (km 18.72) to the top.

Body of water no. 302 - Mittelland Canal

Top (confluence of the Branch Canal into the Mittelland Canal). Limited on three sides by the next bridges.

Body of water no. 303 - Mittelland Canal

Top to Leckermühle (km 54.36).

Body of water no. 304 - Mittelland Canal

From Leckermühle (km 54.36) to the municipal boundary of Wimmer and Schröttinghausen (km 68.5).

Body of water no. 400 — Branch Canal Section 1

From Osnabrück Port to Hollager lock.

- Fishing is prohibited within the fenced (operating) premises and on the east side above the Haster lock.
- Port area, permitted routes: East side: turning point up to and including Römereschbrücke. West side: Leinpfadtor up to and including Römereschbrücke and from the northern end of the Kämmerer loading point to km 12.988. No more than 15 anglers are allowed to fish in the port area at the same time. Blocked sections: Ölhafen from the Haster lock approx. 350 meters down to the gate above the rails.
- The Hellmann employee car park on Elbestraße may be used for fishing in the port area; However, it is mandatory in connection with the NWA parking badge.

Body of water no. 401 — Branch Canal Section 2

From the Hollager lock to the top.


Body of water no. 504 — Alfsee Feeder

From the Sögeln distribution structure to the Dreihorst bridge.

 The operating route NLWKN may only be used from the Dreihorstbrücke (the railway side) with a valid NWA badge soutwards (see signs on the gate).

Body of water no. 505 — Alfsee

- Observe restricted areas (see signs, publication on the internet and illustration on the following page). Entering and wading through the Alfsee is prohibited. Pay attention to the separate signage when approaching the water.
- Observe separate minimum sizes and closed seasons only for the Alfsee on pages 6/7! In the case of minimum sizes not listed in the permit or closed periods, the Lower Saxony inland fishing ordinance applies.

Body of water no. 506 — Riesenfoot

Located in the triangle oft he two railway lines at the feeder in Bramsche-Sögeln.

- Scope of permission (restriction only of the number of rods): 2 rods with any bait.
- Fishing and baiting with boilies is prohibited.
- No fishing tents are permitted, only a fishing umbrella (possibly with a cover) may be used to protect against the weather.
- No night fishing allowed, fishing from calendar sunrise to calendar sunset.
- The NLWKN service route along the feeder is to be driven at walking pace. Driving on the direct water environment (within the gates to the left and right of the pond) is prohibited.

Body of water no. 520 — Holstenteich (Holsten pond) near Ankum At the Ankum-Bippen road.

Body of water no. 530 — Kiesekampsee (Kiesekamp lake)

Behind Engter/Bramsche in the direction of Vörden east of the BAB (Road "Am Gortemasch").

Body of water no. 540 — Lordsee (Lord lake)

Located in the village of Rüssel near Ankum.

- Scope of permission: 1 rod with any kind of bait.
- Fishing and baiting with boilies is prohibited.
- Prohibition to fish from Monday to Friday, fishing is only permitted on Saturdays and Sundays
- Night fishing ban (calender sundown until calender sunrise.
- Removal ban on carp
- The fishing of non-predartory fish is only permitted with soft hooks or pressed barb
- Please observe/follow the current regulations on the scope of permit/restrictions on the homepage www.nwaev.de and in the NWA news.

Body of water no. 560 - Mammutsee (Mammut lake)



Located west of the BAB (Federal motorway) Osnabrück-Bremen, 1 km south of the motorway exit Vörden/Neuenkirchen.






Body of water no. 711 — Buschmannsee without island

Body of water no. 720 — Kleiner (small) Heidesee



Body of water no. 721 — Großer (big) Heidesee

Located between Bad Laer and Glandorf.

- Attention! Pay attention to restricted areas and signposting! See NWA news or homepage for changes. In case of doubt, the office will provide information.
- Caution! On the shores of the Heide lakes (Heideseen) there is a risk of breaking off and thus mortal danger. The NWA and the lessor assume no liability for personal injury or damage to property. According to the official ordinance of the district, open fires and barbecues and the carrying of barbecue equipment are prohibited all year round at all Heide lakes.
- Parking is only permitted in the signposted parking spaces. In the event of infringement, the permit will be withdrawn. Fishing and groundbait in the Kleiner Heidesee is only permitted with maggots and worms. Observe the separate signage when approaching the water body (access opposite the village of Schierloh). Entering the premises of the Niehaus company is not permitted.

Body of water no. 725 — Hengemühlensee



Near the B 70; Access road diagonally across the new Sewage of Rheine.

Body of water no. 727 - Horstmerschsee (NRW)



Located near Brochterbeck in the farming community of Horstmersch.

- Observe blocked sections (danger of breaking off)
- Parking is only allowed on the lake areas surrounded by a fence.

Body of water no. 728 – Knippenbergsee (NRW)



- Parking is only allowed on the lake areas surrounded by a fence.

Body of water no. 730 - Kellinghaussee

Located near Fürstenau (Part of the town Schwagstorf)

Body of water no. 731 – Hollesee

Located in the district of Holle near Hollenstede.

Body of water no. 732 - Schlichthorster Teich (pond) 1

Merzen-Engelern. Located on the road from Schwagstorf to Voltlage, in the immediate proximity to the entrance of the "Engelerner Straße".

Scope of permission (restriction only for the number of rods): 1 rod with any bait. Fishing and baiting with boilies is prohibited. No fishing tents are permitted, only a fishing umbrella (if necessary with a cover) may be used to protect against the weather. No night fishing allowed, fishing from calender sunrise to calendrical sunset.

Body of water no. 734 – großer Dalumer Teich 1 (Big pond of Dalum) Body of water no. 735 - mittlerer Dalumer Teich 2 (Middle pond of Dalum) Body of water no. 736 – kleiner Dalumer Teich 3 (small pond of Dalum) Located at the Leikenweg in Bippen (gravel road east of the Dalumer Straße (K 117) between Bippen towards Fürstenau).

Scope of permission (restriction only fort he number of rods) 2 rods with any bait. No fishing tents are allowed,

only a fishing umbrella (possibly with a cover) may be used for weather protection. No night fishing is allowed, fishing from calendrical sunrise to calendrical sunset.

- It is not permitted to fish both ponds at the same time!
- The small Dalum pond (water body no. 736) is not released for fishing (absolute ban on fishing all year round)!
- There is an all year round prohibition against fishing for this biotope!

Body of water no. 740 – Kronensee 🗪 🗓 ≒ 🛦



- Access only via the Langelager Straße. Access to the premises of the campsite from May to September for NWA members only for fishing; no bathing, no family members and others. The Eastern Bay is only available to NWA members. On all other stretches of the bank, the leisure use by the Kronensee GmbH has priority.

Attention: At certain times the posted signs must be followed!

Fishing ban in the bathing bay from 15.05. until 15.09.

Body of water no. 745 — Larbergsee

Near the village of Achmer (Fürstenauer Damm).

Body of water no. 748— Linner See *-- 🗓 ≒ 🛦

Located in the village of Linne between Wissingen and Schledehausen.

Body of water no. 755 — Niedringhaussee (NRW)



Located in the municipality of Wersen. Not to be confused with the "Präriesee".

Body of water no. 760 — Großer und Kleiner Recker Teich (NRW) (Big and small recker pond)

- (except fort he part belonging to the municipality of Recke: observe the NWA signs)
- Baiting only with maggots and worms, hookbaits of your own choice. Spin fishing with artificial lures is permitted.

Body of water no. 765 - Schleptruper See



- Only belly boat use (not motorized) permitted for the purpose of fishing during the period of use from 01.07. until 31.12. For more rules, see Boat Use in the General Provisions or Chapter 7 on page 10.

Body of water no. 770 – Stockumer See



Located in the village of Natbergen.

- Fishing is only allowed in the areas marked by signs. The lake is closed on hunting days (signs).
- Attention change of route! From now on, the Stockumer See can only be reached via the "Osttor" (east gate) (street Gut [Estate] Stockum). New NWA fishing route: east side and south side up to the NWA sign.

Body of water no. 775 – Mehner Teich (Mehner pond) (NRW)



Located in Stemwede - Niedermehnen near the company "Melle Gallhöfer Dach".

- Driving on the pond area with vehicles is prohibited
- Catch limit for carp and tench, only 1 fish each per day.
- Caution! Due to the high-voltage line and the partial risk of the banks breaking off, there is a danger to life!
- Vehicles must be parked in such a way that agricultural traffic is not obstructed.
- Fishing tents are not permitted, only a fishing umbrella (if necessary with a cover) may be used for weather protection.

Body of water no. 780 - Niedermarker See (NRW)

Located near the city of Lengerich in the farming community of Niedermark.

- 1. Only the numbers indicated in front of the individual water bodies are to be used for the stretches of water.
- 2. Released fish can be entered on a voluntary basis (the letter "Z" for "released" must be entered in the "Weight" field for clarity).
- 3. Please only use the abbreviation letters (see chapter 3.) for the fish species:
- 4. When returning the permit, please mark on the front side whether you have fished.

All fish are to be entered one by one with their length immediately after catching. The weight of the fish may be added later.
